- I agree to provide copies of my valid Class D senior license, insurance card, and registration.
- I agree to provide (2) clear color pictures of my vehicle. One picture will be of the front of my vehicle displaying the license plate. One picture will be of the side of my vehicle.
- ***I agree and understand that if I am not in good academic standing (fail any course, (quarter or final grade), receive a Loss of Credit for any course, or violate the Code of Conduct or School Parking Regulations I may have my student parking privileges revoked for the remainder of the school year.***


