I also understand that all students and their guests are prohibited from attending the Junior Prom under the influence of alcohol or illegal drugs and substances. I understand that the Junior Prom is scheduled **for Friday, March 15th, 2024 from 7:00 p.m. – 11:00 p.m., at Villa Lombardi's in Holbrook**. I understand that I will not be permitted to leave the venue before 11 p.m. unless a parent or other responsible adult comes into the venue to sign me out. I acknowledge that if I violate this contract or the District's Code of Conduct, my parent/guardian will be immediately contacted, I will be sent home from the Junior Prom with my parent/guardian, and I am subject to further disciplinary action which may include, but is not limited to:

1. Violation of the Code of Conduct entered on my student record.
2. Suspension from school.
3. Exclusion from Senior Prom.
4. Exclusion from the Graduation Ceremony.
5. Such other consequences as determined by the building principal.

This contract must be completed and signed by myself, my parent/guardian, my guest and their parent/guardian, in order to purchase my ticket(s) to the Junior Prom. I understand that if I bring a guest to the Junior Prom, who is not a student at Ward Melville High School (information to be filled out on back), I am responsible for that individual's behavior. I understand that I may be subject to the above penalties if my guest violates this contract. I further understand that illegal actions may result in the involvement of law enforcement.
