CALL TO ORDER

The meeting was called to order at 6:00 pm. The Board adjourned into Executive Session at 6:01 pm to discuss legal and contractual matters. The Board reconvened into open session at 7:30 pm. Mr. Carasiti led the pledge of allegiance.

CHANGES IN THE MEETING AGENDA Dr. Fourman noted the addition of a report from the Budget Advisory Committee.

BUDGET ADVISORY COMMITTEE REPORT Dr. Kerman reviewed the Budget Advisory Committee's recommendations.

2007-2008 BUDGET SUMMATION AND REVIEW Mr. Seidell presented the 2007-2008 budget summation. The Board discussed proposed cuts and the impact of such cuts.

It was moved by Mrs. Hamilton, seconded by Mr. Diviney and carried by a 4-3-0 vote with Mrs. Rudman, Mr. McIntosh and Dr. McDonald against that 4th grade band be restored to the budget.

It was moved by Mr. Diviney, seconded by Mr. Micklos and carried by a 6-1-0 vote, with Mrs. Rudman opposed, that one music FTE be restored to the budget.

It was moved by Mr. Micklos, seconded by Mr. McDonald and unanimously carried that a sixth grade guidance counselor be included in the budget.

It was moved by Mrs. Hamilton, seconded by Mr. Micklos and carried by a 6-1-0 vote, with Mrs. Rudman opposed, that an Assistant for Maintenance and Operations and Transportation be included in the budget.

It was moved by Mrs. Hamilton, seconded by Mr. Micklos and carried by a 5-2-0 vote, with Mrs. Rudman and Mr. McIntosh opposed, that one security guard at each elementary school be included in the budget.

ADOPTION OF THE 2007-2008 RECOMMENDED BUDGET, CONTINGENT BUDGET AND PROPERTY TAX REPORT CARD It was moved by Mr. Micklos, seconded by Mr. McIntosh and carried by a 5-2-0 vote, with Dr. McDonald and Mrs. Rudman opposed, that the Board adopt the following resolution:

Upon recommendation of the Superintendent of Schools be it RESOLVED that a budget in the amount of \$152,538,699 be adopted for the 2007-2008 school year, with a contingency budget of \$151,570,266; and be it further RESOLVED that the property tax report card for the 2007-2008 school year be approved.

ADJOURNMENT

There being no further business to be conducted, it was moved by Mr. Micklos, seconded by Mr. Diviney, and unanimously carried that the meeting be adjourned at 9:40 pm.
