CALL TO ORDER Mr. Diviney called the meeting open at 6:13 pm.

MOVE INTO EXECUTIVE SESSION

Mr. McIntosh motioned to move into Executive Session at 6:14 pm in accordance with Open Meeting Law §105 (h) the proposed sale or lease of real property (Nicolls Road – Real Estate Company Interviews), seconded by Mrs. Peritore, and carried by a 4-0-0 vote.

Ms. Mendelson entered the meeting at 6:16 pm.

Dr. Whitney entered the meeting at 6:40 pm.

The Board moved out of Executive Session at 8:05 pm for a brief recess.

**REPORTS** 

Board Member Conference Report Ms. Mendelson presented her conference report for the New York School Board Association's 2011 State Issues Conference.

The conference was productive and discussions included:

- Legislative and regulatory tools to rein in local costs while providing education for students
- Convey destructive impact of state aid cuts and costly mandates to state legislature.
- Preparation for lobbying of state representatives

Ms. Mendelson reported that she spoke directly with local representatives Senator John Flanagan, Chair of the Education Committee and Assemblyman Steve Engelbright as well as Assembly Majority Leader Sheldon Silver and Senate Minority Leader Suzi Oppenheimer and that the representatives were receptive to the concerns presented to them.

Feedback included that the unfunded mandates were now under consideration and that the funding of 4201 schools from local school districts as proposed by Governor Cuomo would not be supported.

Ms. Mendelson encouraged District residents to write to their state representatives and voice their concerns regarding the proposed cuts in educational funding.

2011-2012 BUDGET

Revenue Sources

Mr. Diviney opened with a review of the previous meeting's discussion.

Mr. Carlson presented a summary of the discussion:

Usage of a combination of reserves and fund balance in an amount of \$1.5 million.

Discussion ensued regarding:

- Credit Rating
- Tax Levy
- Discussion ensued with consensus to allow a slight increase over the 3% tax levy proposed by the Board last year. A determination would be made at the conclusion of the budget workshops.

### Program Reduction Review

Level 1 and 2 Program Reductions submitted by Administration

Elementary and secondary school reductions:

Level 1: \$3.7 million Level 2: \$3.1 million

Total: \$6.8 million in reductions

Discussion ensued regarding the individual program reductions presented by Administration.

- Incorporate Board suggestions

- Tax Levy

Ms. Liebowitz presented comments regarding bargaining units.

Mr. Singer made an inquiry regarding capital improvement projects.

Ms. Anderson presented comments regarding the kindergarten program.

Ms. Sarf presented comments on the ability to present public feed back to the Board regarding proposed budget reductions.
