Memorandum of Agreement

2011-2012 BUDGET

Program Reduction Review The Board continued its review of the proposed budget reductions presented by the Administration.

Discussion ensued regarding Level 1 (first round of reductions), Level 2 (next areas for possible reductions), and Contingency reductions (those reductions recommended if the District needs to operate under a contingency budget). A consensus was reached to review a 3.5% tax levy increase vs. the proposed 3% increase to reduce the impact of program reductions. A determination will be made dependent upon state aid and the administration's submission of additional reduction possibilities at the next meeting.

Mr. Lederer noted that discussions continued with the District's bargaining units and the administration will review the budget for any additional reductions.

OTHER RELEVANT ITEMS Mr. Lederer commented on his attendance to *Oliver* at Gelinas Junior High School and recognition by SCOPE to Anthony Pollera for his outstanding contributions as an educator.
