Establishment of 2008-2009 Tax Levy

Upon the recommendation of the Superintendent of Schools be it RESOLVED that the Board of Education adopt a school district tax levy for the Town of Brookhaven portion of the district of \$115,287,551 and for the Town of Smithtown portion of the district of \$1,636,943 for a total 2008-09 tax levy in the amount of \$116,924,494.

Information received from the town tax assessors indicates a .73% reduction in Brookhaven assessed values and a 2.05% reduction in Smithtown assessments. AS a result, the Audit Committee has decided to recommend a tax levy that is \$437,500 less than what was included in the 2008-2009 budget, in order to offset some of the impact of the reduction in assessed value. This decrease in tax levy will be made up for by increasing the amount of applied fund balance from \$2,600,000 to \$3,037,500.
