Preliminary Review of Financial Plan and Budget 2013-2014	Mr. Carlson presented the Preliminary Review of Financial Plan and Budget 2013-2014. Mr. Carlson noted that State Aid to the district will be \$928,000.00 more than expected. In addition, due to the efforts of Senator Flanagan and Assemblyman Engelbright, the district will be receiving \$100,000.00 in legislative aid.
