CALL TO ORDER

The meeting was called to order at 6:00 pm. The Board adjourned into Executive Session at 6:01 pm to discuss legal and contractual matters. The Board reconvened into open session at 8:05 pm. Brittany O'Shea led the pledge of allegiance.

PUBLIC PARTICIPATION

Preston Seader, a student at Mount Elementary, spoke about the problems with busses and the dismissal situation at Mount. Michael Radesco spoke about safety issues and the staging areas used during dismissal at Mount. Howard Kipnes spoke about the loss of instructional time at Mount due to transportation problems. Monica Aguinaldo spoke about safety issues during dismissal at Mount.

Caryann Sells asked if a revision is being made to the Board Policy regarding 8<sup>th</sup> graders playing junior varsity or varsity sports. Mr. Carasiti noted that Mr. Webster will be making a report regarding this matter later in the meeting.

Sarah Andersen spoke regarding classifying cheerleading as a sport rather than a club or activity.

Brittany O'Shea reported on Trick or Treat Street, the upcoming CYS Craft Fair, and the musical production of West Side Story at Ward Melville High School.

CHANGES IN THE MEETING AGENDA There were no changes to the meeting agenda.

**MINUTES** 

It was moved by Mr. McIntosh, seconded by Dr. McDonald, and carried by a 5-0-1 vote, with Mrs. Rudman abstaining, that the Board approve the minutes of the September 12, 2006 Board meeting.

**REPORTS** 

Mr. Carasiti reviewed the proposed plan and schedule for dissemination of information regarding the upcoming bond referendum.

School Plan for Results: Elementary The Elementary School Principals presented the Elementary School Plan for Results. Dr. McDonald noted that the plan would be discussed further at the upcoming meeting of the Teaching and Learning Committee, which is set for Thursday, November 30 at 7:00 pm.

Athletic Selection Classification Report and Recommendations In response to earlier public comment Mr. Webster advised that cheerleading is not recognized as a sport by New York State, but the district considers cheerleaders an integral part of the athletic program.

Mr. Webster presented the Athletic Selection Classification Report and Recommendations.

# INFORMATION ITEMS TO THE BOARD

Dr. Lewis reviewed the Course Proposals for 2007-2008. The procedure for removing course offerings was discussed, including reviewing courses for relevance. The possible impact on existing courses as a result of adding new courses was discussed. Budget considerations were discussed. The Board asked that the item be put on the next agenda.

Course Proposals for 2007-2008

Mr. Diviney explained that a request was made to put a sign and benches on property that belongs to Gelinas indicating that it is part of a historic district. Mr. Miller, a representative of the BCALH explained the proposal for a streetscape garden, and noted that the BCALH would maintain the area.

BCALH Historic District Proposal

It was moved by Mr. Diviney, seconded by Dr. McDonald, and unanimously carried that the Board approve the proposal of the BCALH to use the identified portion of property in the manner described.

Transportation Status Report Regarding Mount Mr. Seidell reported on the transportation situation at Mount. The matter was discussed at length by the Board, Mr. Seidell, and Joe LoGelfo, the regional manager of Atlantic Express Bus Company. Mr. Seidell noted that a shortage of qualified bus drivers is contributing to the situation. Mr. Carasiti explained that staging areas were set up as a safety measure while students are waiting for the busses.

Designation of Authorized Signature on Checks for Extra-Curricular Activity Funds – 2006-2007 It was moved by Dr. McDonald, seconded by Mr. McIntosh, and unanimously carried that the Board adopt the following resolution:

- a. <u>Setauket ES SED #58-002-01-06-0-001-025</u>
  - 1. Replace existing wood play structure & remove pea gravel. Also install handicapped surfacing.
  - 2. Replace existing student cubbies throughout the building.
  - 3. Reconfigure kitchen/serving area to allow more flexibility within existing cafeteria. Also replace perforated ceiling & lighting within kitchen/serving area, along with reconfiguration of doors and frames from kitchen serving area to corridor.
  - 4. Reconfigure Speech/Discover & Reading Centers to provide (4) spaces. Currently the spaces are divided into (7) small spaces.
  - 5. Reconstruct Locker Room to create additional instructional space

  - 10. Replace Fire Alarm System with ADA compliancy & replace/upgrade emergency lights.
  - 11. Replace broken/missing exterior fixtures to restore to original appearance.
  - 12. Provide additional accessible drinking fountains so at least 50% on each floor are accessible. Create handicapped work stations in Classrooms & Cafeteria.
  - 13. Repave upper main lot/curbing/drainage
  - 14. Create parent drop-off at location of old Maintenance & Operations building.
  - 15. Installation of handicapped work spaces and Cafeteria tables.
  - 16. VAT abatement throughout the building. Replace/new VCT & cove base.
  - 17. Complete replacement of existing building forced hot air system. Furnish & install new hot water boilers, classroom unit ventilators and exhaust fans & demolition, piping & electric to all.
  - 18. Toilet Reconstruction finishes, ventilation, plumbing & electric.

  - 1. Convert Locker Room to adaptive Phys Ed (Boys') & small group (Girls').
  - 2. Create additional small group instructional spaces/offices and frame will also be replaced.
  - 3. Replace perforated ceiling & lighting in Kitchen. Kitchen will also be reconfigured for access from Room 15. Door and frame will also be replaced.
  - 4. Exterior masonry/steel lintel replacement is required at multiple locations throughout the building.
  - 5. VAT flooring throughout the building & replace with new VCT & cove base.
  - 6. Upgrade Boiler Room equipment and ensure compliance with current code violations.
  - 7. Install air handling/unit ventilator system in rooms which currently do not meet the requirements of fresh air ventilation.
  - 8. All classrooms which receive fresh air which is being introduced through the unit ventilator via fixed grills in the classrooms have been sealed closed. Approximately 50 classrooms require this venting. Grills will be reopened by installing gravity dampers.
  - 9. Install new exterior pole lighting & replace/upgrade lighting in various areas.
  - 10. Fire Alarm System reconstruction
  - 11. Replace PA/Intercom System.
  - 12. Install handicapped work spaces & cafeteria table & also provide additional accessible drinking fountains
  - 13. Replace existing storm drain line plus repair/replace water infiltration problem.
  - 14. Replace curbing & sections of sidewalk along bus loop. Main asphalt parking lot to be reconstructed. Remove existing wood framed portable classroom to provide additional parking.

- 2. Convert existing Locker Room facilities into a small adaptive physical educational space.
- 3. Reconfigure Kitchen serving area & partial replacement of existing Kitchen equipment.
- 4. Exterior masonry/steel lintel replacement required at multiple locations throughout the building.
- 5. VAT removal of existing flooring throughout the building. Replace with VCT and cove base.
- 6. Removal of exterior door surrounds & columns that are severely rotted and damaged.
- 7. Replace existing corridor classroom & corridor ceilings.
- 8. Upgrade Boiler Room equipment and current code violations.
- 9. Reconstruction of PA/Intercom System to subdivide room and areas presently not covered.
- 10. Install handicapped work spaces in classrooms & Cafeteria tables
- 11. Provide additional accessible drinking fountain in accordance with ADA.
- 12. Reconstruction of several existing toilets to meet ADA guidelines plumbing, ventilation, demolition, fixtures, partitions & electrical work.
- 13. Replace existing curbing along existing bus loop and sections of asphalt sidewalk.
- 14. Replace rotted classroom casework, cubbies, wardrobes, & sink unit with new. Provide handicapped accessibility where applicable.
- 15. All classrooms which receive fresh air which is being introduced through the unit ventilation via fixed grills in the classrooms have been sealed closed. All classrooms require this venting. Grills will be reopened by installing gravity dampers.
- 16. Install air handling/unit ventilator system in rooms which currently do not meet the requirements of fresh air ventilation.
- 17. Complete pneumatic rehabilitation of all existing mechanical equipment within the building.

## d. Arrowhead ES - SED #58-002-01-06-0-007-018

- 1. Provide (4) packaged A/C units for (10) classrooms. This will provide A/C to Special Education program which is housed at this building in the summer.
- Provide wood play structure & swing set install handicapped surfacing - ADA. Creation of new asphalt play area at north end of site and connect doors at end of wing with asphalt walkway.

- 3. Renovate Kitchen/Serving Line to improve better flow during distribution of food to students. There will be also a partial replacement of existing kitchen equipment. Perforated ceiling & lighting will be replaced and new non-perforated scrubbable ceiling & grid will be installed along with new lighting & occupancy sensors.
- 4. Exterior masonry/steel lintel replacement at multiple locations throughout the building. All exterior joints will be racked out and recaulked.
- 5. VAT removal throughout the building. Replace with VCT and cove base.
- 6. Repair severely rotted and damaged exterior door surrounds and columns.
- 7. Install air handling/unit ventilator system in rooms which currently do not meet the requirements of fresh air ventilation.
- 8. Replace existing PA/Intercom & Clock Systems
- 9. Replace front bus loop concrete/asphalt sidewalk.
- 10. Replace existing concealed spline ceiling throughout the building.
- 11. Install handicapped work spaces and Cafeteria tables. Provide additional accessible drinking fountains
- 12. All classrooms which receive fresh air which is being introduced through the unit ventilator via fixed grills in the classrooms have been sealed closed. All classrooms require this venting. Grills will be reopened by installing gravity dampers.
- 13. Replace rotted classroom casework, cubbies, wardrobes & sink unit with new. Provide handicapped accessibility where applicable.

# e. Paul J. Gelinas JHS - SED #58-002-01-06-0-008-025

- 1. Auditorium Reconstruction will include the replacement of the existing Stage & House Lighting, Dimmer Boards, Sound System, replacement of Auditorium Seating & flooring, as well as the refinishing of existing stage floor. This will also include the replacement of auditorium doors, & ADA accessibility.
- 2. Renovate (2) existing large Multi-Purpose Room 313/Wood Shop. This work shall include flooring, ceiling replacement, lighting replacement, casework, equipment and ventilation reconstruction.
- 3. Reconstruction of (4) existing Art Rooms, including storage areas and dark room. (1) Art Room will be converted into a Home Economics Room, smaller Home Ec Room will be used as a General Purpose classroom. There will be replacement of ceiling, lighting and flooring, as well as replacement of cabinetry, tables, creation of additional storage space and variable speed exhaust for the Dark Room, along with proper

- ventilation/exhaust for Art & Home Ec Rooms.
- 4. Music Suite: Addition of new space (3,100 sq. ft.) to alleviate overcrowded condition. New road along side of building will provide access for deliveries. Reconstruction of existing Music area, as part of this scope work.
- 5. Kitchen Replace existing dishwasher away from front of room, remove interior walls & doors to allow for smoother serving area, and also replace ceiling & lighting.
- 6. Provide Asphalt Parking areas at east parking lot, replace curb & sidewalk along front entrance, and replace asphalt walk at rear of building.
- 7. Replace (4) tennis courts, replace basketball courts, aerate & seed athletic fields.
- 8. Extend duct from elevator shaft through roof.
- 9. Replace concealed spline ceiling/lighting where needed and on 1st floor corridor.
- 10. VAT abatement throughout the building and replace new VCT & cove base.
- 11. Exterior masonry/steel lintel replacement is required at multiple locations throughout the building.
- 12. Provide (2) pair of smoke doors at Courtyard.
- 13. Install air handling/unit ventilator system in rooms which currently to not meet the requirements of fresh air ventilation. 2nd floor requires floor venting & 1st floor required dampers.
- 14. Install handicapped work spaces & cafeteria tables & also provide additional accessible drinking fountains
- 15. Convert (1) pair Boys'/Girls' & Faculty toilets to be handicapped accessible.
- 16. Provide asphalt walk at rear of building.
- 17. Replace curb & sidewalk along front entrance. Repave asphalt parking lot adjacent to fields & Kitchen entrance, also replace front bus loop concrete/asphalt sidewalk.
- 18. Replace (4) Tennis Courts, also replace Basketball Courts. Provide access around east side of building and regrade/rototil/top dress/aerate & seed Athletic Fields.
- 19. Reconstruction of existing main parking lot including pavement, curbing, sidewalks & drainage.
- 20. Complete pneumatic rehabilitation of all existing mechanical equipment within the building.

### f. Minnesauke ES - SED #58-002-01-06-0-014-018

1. Repave existing bus loop, parking lot, including all sidewalks & curbing. Provide new drainage & reconfigure bus loop to better serve the increased population.

- 2. Replace wood playground equipment and swing set including handicapped surfacing ADA
- 3. Kitchen reconstruction replace existing dishwasher to rear of kitchen, removal of interior walls to allow for a smoother flowing serving area, replace (2) refrigerators with pass-through refrigerator, (1) computer & (1) stainless steel table with shelf. Also proper ventilation will be provided thus omitting the need for new ceiling fans. Replace existing perforated ceiling & lighting within Kitchen/serving area.
- 4. Exterior masonry reconstruction & miscellaneous steel lintel replacement is required at multiple locations throughout the building.
- 5. Upgrade Boiler Room equipment and current code violations.
- 6. Install air handling/unit ventilator system in (7) student & teacher occupied areas which currently do not meet the requirements of fresh air ventilation.
- 7. Install new stage lighting & dimming system, as well as a new sound system in the Auditorium.
- 8. Reconstruction of several existing toilets to meet ADA guidelines plumbing, ventilation, demolition, fixtures, partitions and electrical work.
- 9. Provide additional accessible drinking fountains in accordance with ADA.
- 10. Address flooding issue outside various classrooms provide proper storm drainage structures.
- 11. Replacement of existing VAT throughout building. Replacement of VCT and cove base.
- 12. Reconstruction of existing cupola.
- 13. Replace existing rotted Kitchen exhaust ductwork.
- 14. Replace corridor ceilings and reinsulate attic space in rear Gym corridor.
- 15. Replace rotted classroom casework & sink units with new. Provide handicapped accessibility where applicable.
- 16. Install handicapped work spaces & Cafeteria table.
- 17. All classrooms which receive fresh air which is being introduced through the unit ventilator via fixed grills in the classrooms have been sealed closed. Approximately (50) classrooms require this venting. Grills will be reopened by installing gravity dampers.
- 18. Complete pneumatic rehabilitation of all existing mechanical equipment within the building.

# g. Robert C. Murphy JHS - SED #58-002-01-06-0-015-021

1. Complete reconstruction of (2) 1st floor Science Rooms - ventilation, demolition, VAT, casework, plumbing finishes & electrical work.

- 2. Auditorium Reconstruction includes the replacement of existing stage & house lighting, sound system, the replacement of the auditorium seating & flooring, also replacement of existing stage curtains, as well as the refinishing of existing stage floor. There will also be provision for A/C and acoustical treatment to walls & ceiling.
- 3. Renovate (4) existing Art Rooms, including adjacent storage areas & dark room. (1) Art Room will be converted into a Home Economics Room. The smaller Home Ec Room (302) will be reclaimed to a general purpose classroom. Casework & furniture in existing Rm 302 will be reused in renovated Home Ec Room. There will be replacement of ceiling, lighting & flooring, as well as replacement of cabinetry, tables and creation of additional storage space. Variable exhaust will be created for proper ventilation in the Art Room & Home Ec Rooms.
- 4. Music Suite: Addition of new space (3,100 sq. ft.) to alleviate overcrowded condition. New road along side of building will provide access for deliveries. Reconstruct existing music areas as part of this work scope.
- 5. Kitchen reconfiguration & replacement of metal pan perforated ceiling & lighting.
- 6. Kitchen: Replace existing dishwasher away from front of room, remove interior walls & doors to allow for smoother serving area and also replace ceiling & lighting.
- 7. Upgrade Boiler Room equipment and current code violations
- 8. Provide (2) smoke doors from existing Courtyard.
- 9. Proper ventilation is to be provided for 2nd floor Chemical Storage Room.
- 10. Classroom fresh air relief 2nd floor ventilation & 1st floor dampers.
- 11. Provide new PA/Intercom System
- 12. Install handicapped work spaces & cafeteria table. Also additional ADA drinking fountains. Conversion of Boys' & Girls' bathrooms for handicapped accessibility.
- 13. Replace sidewalk & curbing along front entrance. Asphalt parking areas will also be repaved, including the main parking lot.
- 14. Replace (4) Tennis Courts & (2) existing exterior Basketball Courts.
- 15. Complete reconstruction of existing Athletic Fields regrade/rototill/top dress/aerate & seed.
- 16. Reconstruction of existing main parking lot including pavement, curbing, sidewalks & drainage.
- 17. Complete pneumatic rehabilitation of all existing mechanical equipment within the building.

- 1. Remove existing wood framed Art Portable & adjacent overhand.
- 2. Create 2<sup>nd</sup> Computer Center in C-wing to be used as primary Computer Lab.

- 4. Provide CCTV Security System to entire building.

#### b. Nassakeag ES - SED #58-02-01-06-0-002-020

- 1. Band Room relocation to 1<sup>st</sup> floor to comply with handicapped accessibility.
- 2. Convert Room 33 to Science Room & Room 32 to Art Room. This will put both Art Rooms in proximity to each other.
- 3. Convert Room 41 to 2<sup>nd</sup> Computer Lab.
- 4. Provide CCTV Security System to entire building.

# c. William S. Mount ES - SED #58-02-01-06-0-006-020

- Reconstruction of existing interior teaching spaces to create 6<sup>th</sup> grade centers.
- 2. Provide CCTV Security System to entire building.

### d. Arrowhead ES - SED #58-02-01-06-0-007-019

- Convert Locker Room to Life Skills Room w/access from Boys' Locker Room side. Relocate the Men's Phys Ed Office & reclaim a portion of existing locker room area into gym storage space.
- 2. Addition of 6,000 sq. ft. to include (4) new classrooms. (2) Classrooms are required due to increase in enrollment and (2) will house 6<sup>th</sup> grade based on programmatic needs. Additional Faculty Toilet will be house within this addition.
- 3. Room 38 will be converted into a 6<sup>th</sup> grade Computer Center & Room 40 into a 6<sup>th</sup> grade Science Lab.
- 4. Provide CCTV Security System to entire building.

# e. Paul J. Gelinas JHS - SED #58-02-01-06-0-008-024

- 1. Install air handling/unit ventilators in student spaces which currently do not meet the requirements of fresh air ventilation.
- 2. Replace Fire Alarm System w/new ADA compliant system.
- 3. Replacement of PA/Intercom System (areas currently not covered). Replace vandalized speaker & front end equipment.
- 4. Provide new CCTV Security System.
- 5. Install new Master Clock System to cover entire building.

#### f. Minnesauke ES - SED #58-02-01-06-0-014-019

- 1. Interior reconstruction to create Science Lab convert (37) existing resource rooms into 6<sup>th</sup> grade Science Classrooms.
- 2. Provide CCTV Security System for the entire building.

#### g. Robert C. Murphy JHS - SED #58-02-01-06-0-015-022

- 1. Installation of Air Handling/Unit Ventilator System in rooms which currently do not meet the requirements of fresh air ventilation.
- 2. Replacement of Fire Alarm System
- 3. Provide new CCTV Security System
- 4. Installation of new Master Clock System

# h. <u>Three Village CSD – District Wide - SED #58-02-01-06-7-999-</u>004

1. Installation of a new Wide Area Network System (WAN).

Whereas, in 1995, amendments were made to the SEQRA Regulation (Part 617) to classify projects, which will be excluded from the requirements for the preparation of an Environmental Impact Statement (Type II Actions). The projects mentioned above are now classified as Type II Actions as determined by 6NYCRR§617.5 and

Whereas, these projects fall under the following categories:

- A. Routine Maintenance and Repair 6NYCRR§617.5 (c)(1): Maintenance or repair involving no substantial change in an existing facility.
- B. Replace or Rehabilitation 6NYCRR§617.5 (c)(2): replacement or rehabilitation or reconstruction of a structure of facility, in kind, on the same site, unless the work excess a threshold for a Type I action in 6NYCRR§617.4.
- C. 6NYCRR§617.5(c)(8); Routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings.

Therefore, as the lead agency for the SEQRA determination, all the above referenced projects fall under Categories "A" or "B" above. The procedure for Type II Actions, with regard to the SEQRA Process for Capital Projects noted above is "No Additional Required Action under 6NYCRR§617.5(a)".

The project mentioned above is now classified as Type II Actions as determined by 6NYCRR§617.5 and Whereas, this project fall under the following categories:

- A. Routine Maintenance and Repair 6NYCRR§617.5 (c)(1): Maintenance or repair involving no substantial change in an existing facility.
- B. Replace or Rehabilitation 6NYCRR§617.5 (c)(2): replacement or rehabilitation or reconstruction of a structure of facility, in kind, on the same site, unless the work excess a threshold for a Type I action in 6NYCRR§617.4.
- C. 6NYCRR§617.5(c)(8); Routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings.

Therefore, as the lead agency for the SEQRA determination, the above referenced project falls under Categories "A" or "B" above. The procedure for Type II Actions, with regard to the SEQRA Process for Capital Projects noted above is "No Additional Required Action under 6NYCRR§617.5(a)".
